Responsibilities of Lanz Mechanical

- 1. Supply of new equipment with specifications engineered to your application as detailed in quotation.
- 2. To provide all labour required for maintenance and service of the equipment, including:
 - Regularly scheduled Preventative Maintenance (PM) and Periodic Inspection service as per the Operation & Maintenance Manual
 - All normal, routine and emergency repairs
 - · Major work including rebuilds and overhauls if necessary
 - Electrical work and related services (except lights bulbs)
- 3. To provide all parts required for maintenance and service of the equipment
- 4. To provide a replacement machine, of similar specifications, subject to availability, on a nocharge basis including cartage, in the event repairs (excluding those caused by damage, abuse, negligence and/or misapplication) cannot be completed within two working days after notification
- 5. Maintaining and managing an inventory of spare parts and materials at your facility if necessary
- 6. To provide a Lanz Mechanical certified service technician on your site, as required, for the length of the maintenance agreement, to service all equipment provided by Lanz Mechanical
- 7. To provide factory training to our service technicians to meet the manufacturers standards and certification requirements
- 8. To provide copies of all service reports
- 9. Coordinating rental equipment maintenance with your personnel/systems
- 10. All planned maintenance will be performed in addition to any necessary repairs for any piece of equipment covered by the agreement required because of the normal operation of the equipment
- 11. Exclusions:
 - Charges incurred because of damage, abuse, negligence and/or misapplication
 - Cost of tire repair and/or replacement
 - Light bulbs

Responsibilities of the Hirer

- 1. To provide competent trained operators of the equipment.
- 2. To perform, and log, a pre-shift inspection at the beginning of each shift for each machine in accordance with the manufacturers pre-shift operation check list.
- 3. To provide all necessary electricity and water required for the use of the equipment and batteries in its daily operation.
- 4. To notify Lanz Mechanical in the event of a problem or malfunction with the equipment.
- 5. To notify Lanz Mechanical in the event of any malfunction of any hour meter. Lanz Mechanical will repair or replace the hour meter on a no-charge basis providing the malfunction was not caused by damage or abuse.

- 6. To not sell, assign, pledge, mortgage, underlet, lend or part with the possession of the equipment
- 7. To store the equipment in a secure compound when not in use. The **hirer's** premises as shall be deemed secure
- 8. Operate the equipment except in accordance with the equipment manufacturer's load carry specifications (capacity/specification manual to be provided) and in the manner for which it was designed
- 9. To provide comprehensive general liability insurance with a minimum limit of one million dollars (\$1,000,000.00) combined single limit (property damage and bodily injury) for equipment, and fire and theft coverage; and provide Lanz Mechanical with certificates of insurance.
- 10. To pay all applicable sales taxes.
- 11. To provide a safe, dry and warm working area for our mechanics.
- 12. To have equipment available for regularly scheduled planned maintenance service.
- 13. To pay any charges incurred because of damage, abuse, negligence and/or misapplication.
- 14. To pay for tire repair and/or replacement.
- 15. To return the equipment complete with forks, batteries, battery chargers and attachments in the same condition as when delivered, less normal operating wear-and-tear, and with tires having 50% or more tread remaining, freight prepaid to our premises; at the end of the rental term.
- 16. To carry forth the agreement herein to the full extent of the Term Period.

Rental Agreement Termination

In the event the **hirer** wishes to terminate the Rental Agreement; the **hirer** will be liable for 50% of the remaining cost of the Rental Agreement and will be obligated to provide payment for this cost in full within 6 months from the termination date.

Additional Labour Rate

In the event additional labour is required to repair equipment not covered by the above agreement and/or caused by damage, abuse, negligence and/or misapplication, the following will apply:

Warranty (Additional Labour)

After the initial repair, further repairs and/or adjustments required within sixty days, or three hundred hours, whichever comes first, will be performed free of labour service and parts charge provided:

- 1 The need for this repair was not required because of subsequent damage, abuse, negligence and/or misapplication
- 2 The customer was not made aware of the problem, and the need for corrective action, at the time of the original service

Other Collateral Benefits of a Rental Plan with Guaranteed Full Maintenance

- 1. A monthly budgeted payment 'locked in' for the term of the agreement.
- 2. Elimination of idle equipment: you can operate your minimum annual equipment requirement. Supplemental equipment will be made available for peak season and temporary needs at preferential short-term rates.
- 3. Elimination or reduction of hidden costs such as equipment and parts obsolescence, parts inventory costs, pilferage, executive and administration time, loss of productivity due to equipment downtime, etc.
- 4. Consultation service on material handling problems during the term of the agreement.
- 5. Availability of a "Driver Training Program".
